Ownership Equity Agreement

Ownership in The South Royalton Market is open to all. Although your equity investment is recognized without a stock certificate, the Market maintains a record of investors. Your investment provides you the opportunity to vote in elections of the Board of Directors and on all issues that come before the annual meeting of members.

A payment is not entitled to a dividend and is not transferable. Equity payments are subordinate to all other debts of the Market.

When a member leaves The South Royalton Market for any reason, the equity that they have invested will be refunded upon request.

How do I run for the Board of Directors?

Any member can become a candidate for the Board. Interested persons should fill out a Statement of Intent at the Market. Statements will be posted before the Annual Meeting.

What happens if I move?

You may leave your membership fee in the Market to continue to support it in your absence, or withdraw your funds.

How can I purchase food in bulk or case lots for a discount?

Member-only sales are posted in the store each month.
